# GUIDLINE AND SANITORY REQUIRMENT TO IMPORT ANIMAL ORIGIN ORGANIC FERTILIZER TO SRI LANKA

According to the section 21 of the Animal Disease Act, No,59 of 1992 which state no person shall import any animal, animal product, veterinary biological, animal semen or embryo except under the authority of a permit issued under this act by the controller of Import and Export on recommendation of the Director General of Department of Animal production and health.

Guideline to be fulfilled by the importer to issue the recommendation to import animal based organic fertilizer.

- i. The organic Fertilizer should be sterile and comply with SLSI standards.(SLSI 1704:2021)
- ii. The exporting country should be free of major economically important diseases like Bovine Spongiform Encephalopathy, Foot and Mouth Disease, African swine fever. Anthrax, High & Law Pathogenic Avian Influenza.
- iii. The product should be free of antimicrobial residues and metabolites of residues
- iv. The importer should submit the dully filled application along with following documents.
- a. Country of origin certificate.
- b. Details of the processing procedure of the product.
- c. Source of the fertilizer certified by relevant authority of exporting country.
- d. Sterility report issued by accredited laboratory of the exporting country or relevant Authority
- e. Specimen of the International Veterinary Certificate issued by the Government veterinary authority of exporting country.

### Veterinary health requirements

The Veterinary Authority of exporting country should be certified,

- 1.That the country is free from major economically important diseases like Bovine Spongiform Encephalopathy, Foot and Mouth Disease, African swine fever. Anthrax, High & Law Pathogenic Avian Influenza.
- 2. The product is free of antimicrobial residues and metabolites of residues.
- 3. The product is free from any pathogenic animal or zoonotic causative organisms
